Sunday, October 13, 2024

Depart from York, PA and travel to your overnight stop where lodging has been arranged for you (*pack an overnight bag*); dinner is on your own this evening.

Monday, October 14, 2024

After breakfast, check out and depart for **Charleston, SC** where you will meet your guide for a **Historic Charleston Tour**. Charleston is one of the most beautiful and historic cities in the South and it features stately homes with lovely gardens, magnificent public buildings and majestic churches. During your tour you will see Charleston City market, White Point Garden, Rainbow Row, Old Exchange Building, Four Corners of Law, Site of Gadsden Wharf, U.S. Custom House, Ashley Hall, The Battery, College of Charleston and several historic churches including the Circular Congregation Church, St. Michael's Church and the Cathedral of St. John the Baptist. After the tour, enjoy **dinner** at a local restaurant before checking into your hotel.

Tuesday, October 15, 2024

Enjoy breakfast, then head for **Boone Hall Plantation & Gardens**, founded in 1681 when Englishman Major John Boone came to Charleston and established a lucrative plantation and gracious home on the banks of Wampacheone Creek. The family and descendants of Major Boone were influential in the history of South Carolina, the colonies and the nation. The mansion that exists today which was built in 1936 by Canadian ambassador Thomas Stone. **Guided tours of the first floor** allow you to see how a Coastal Carolina planter's family lived. From here, explore the **formal gardens, grounds and slave cabins** located on the estate and enjoy a live **performance of "Exploring the Gullah Culture" at the Gullah Theater**. There will be time for lunch on your own in Charleston's historic area before departing for an afternoon relaxing **harbor cruise to historic Fort Sumter**. Upon arrival you will be greeted by National Park Service Rangers, who will provide further details about Fort Sumter and its pivotal role in the American Civil War. On the fort you will find a very informative museum with many historic artifacts and a museum store. After your roughly one-hour visit, you will enjoy a soothing cruise back to your departure point where you will depart for **dinner** before returning to your hotel for the evening.

Wednesday, October 16, 2024

After breakfast, check out and travel to **Savannah, GA** where you will enjoy a delicious southern **family-style lunch at Paula Deen's The Lady & Sons Restaurant**. Later, meet your guide for a **2-hour tour** of one of the largest restored National Historic Landmark Districts in the nation. You will see 2.2 square miles of the Historic District showing over 270 years of rich history with its restored 18th and 19th century buildings and the waterfront where cotton warehouses are now restaurants, hotels, and shops. This beautiful city eloquently displays exquisite ironwork, ancient cobblestones, splendid mansions and picturesque cottages. You will see and hear about Factors Walk, Trustees Garden, City Market, and Colonial Cemetery. At the conclusion of the tour, depart for **Savannah's River Street District** where you can browse in the unique shops and enjoy dinner on your own at one of the fine restaurants before checking into your hotel for the evening.

Thursday, October 17, 2024

Following breakfast, check out and spend some free time in **Savannah's Old City Market** area where you will find a wide array of restaurants and shops in the location that has been the hub of the city's social and business activity for centuries. Enjoy lunch on your own at one of the restaurants, then depart for your overnight stop for lodging (*pack an overnight bag*); dinner is on your own this evening.

Friday, October 18, 2024

Following breakfast, check out and depart for home with fond memories of **Charleston & Savannah**.

Terms & Conditions

Deposit & Final Payment: An initial deposit must be paid at the time the reservation is originated. The cancellation schedule observed will be that of the respective provider (airline, cruise line, tour operator, or transportation provider etc. as the case may be) of travel services ("Supplier"). Prices are subject to change due to fuel charges and other Supplier charges. Airline tickets purchased are non-refundable. Final payment is due as per the Travel Leaders Vacation Center ("TLVC") invoice provided. Once the final payment is paid, the booking becomes non-refundable.

Cancellation Policy: The deposit cancellation policy observed will be the Supplier's current policy. TLVC will assess a cancellation fee in the amount of \$50 per person in addition to the Supplier's current cancellation policy. The TLVC cancellation fee must be paid at time of cancellation. The cancellation penalties are provided by each Supplier. See the registration form for any additional or specific booking penalties.

Documents: You will receive your documents including luggage tags, cruise and tour documents, daily itinerary and any other relevant travel documents at a final meeting to be held on a future date to be agreed upon with TLVC in advance of the day of travel.

Luggage/Baggage: Additional charges will apply based on specific airline rules and flight schedule. The Supplier may have a limit of one bag per person plus a carryon. Further information will be supplied by your travel advisor regarding any specific requirements.

Proof of Citizenship: You will need a REAL ID-compliant driver's license, photo ID card or another form of federally acceptable identification for any US tours. A valid passport is required to have at least 6 months validity past return date for any tour or cruise outside of U.S. Please check with our travel advisor for the most up-to-date requirements.
