

Monday, December 2

Depart from your hometown and travel to your overnight stop where lodging has been arranged for the group. (pack an overnight bag)

Tuesday, December 3

Following breakfast, check out and continue to the **Smoky Mountain Region of Tennessee**. Arrive in the Pigeon Forge, TN area where you will check into your lodging. You will have time to freshen up before departing for the **Dolly Parton's Stampede Dinner Show**. The live nativity scene is both dramatic and spectacular. The true meaning of Christmas comes alive as the three kings ride atop camels on their way to Bethlehem. The stunning beauty of angels will amaze you as the songs inspire all ages. No holiday celebration would be complete without good 'ole St. Nick. Young and old await the arrival of Santa atop his authentic sleigh full of goodies. The entire cast of performers including 32 magnificent horses will take you on a nostalgic holiday adventure with your favorite Christmas songs.

Wednesday, December 4

Breakfast, then meet your guide for a **tour of the majestic Smoky Mountains**, located between North Carolina and Tennessee. America's most visited national park is world renowned for its diversity of plant and animal life, the beauty of its mountains and Southern Appalachian Mountain culture. After lunch on your own in Gatlinburg, visit the **Ole Smoky Tennessee Moonshine Distillery for a tour and tasting**. Later, you will have a guided tour at the **RMS Titanic Museum** attraction. Through interactive exhibits, learn what it was like on the RMS Titanic. Discover your passenger or crew's fate in the Titanic Memorial Room where 2,208 names line the historic wall. Terms & Conditions

Deposit & Final Payment: An initial deposit must be paid at the time the reservation is originated. The cancellation schedule observed will be that of the respective provider (airline, cruise line, tour operator, or transportation provider etc. as the case may be) of travel services ("Supplier"). Prices are subject to change due to fuel charges and other Supplier charges. Airline tickets purchased are non-refundable. Final payment is due as per the Travel Leaders Vacation Center ("TLVC") invoice provided. Once the final payment is paid, the booking becomes non-refundable.

Cancellation Policy: The deposit cancellation policy observed will be the Supplier's current policy. TLVC will assess a cancellation fee in the amount of \$50 per person in addition to the Supplier's current cancellation policy. The TLVC cancellation fee must be paid at time of cancellation. The cancellation penalties are provided by each Supplier. See the registration form for any additional or specific booking penalties.

Documents: You will receive your documents including luggage tags, cruise and tour documents, daily itinerary and any other relevant travel documents at a final meeting to be held on a future date to be agreed upon with TLVC in advance of the day of travel.

Travel Protection: We offer Travel Protection to cover your investment in case you need to cancel the trip for medical reasons or if the trip is cancelled due to supplier interruptions. Travel Protection must be purchased no later than 14 days after the first deposit has been made for coverage on medical pre-existing conditions. Plan costs are based on total trip cost and age PER PERSON. Travel Protection is non-refundable and non-transferable. You receive basic coverage in the event of unforeseen trip-related expenses such as: Trip cancellation, interruption, and delay; emergency medical treatment or evacuation; Lost, stolen or damaged baggage or travel documents; and baggage delay.

Luggage/Baggage: Additional charges will apply based on specific airline rules and flight schedule. The Supplier may have a limit of one bag per person plus a carryon. Further information will be supplied by your travel advisor regarding any specific requirements.

Proof of Citizenship: You will need a REAL ID-compliant driver's license, photo ID card or another form of federally acceptable identification for any US tours. A valid passport is required to have at least 6 months validity past return date for any tour or cruise outside of U.S. Please check with our travel advisor for the most up-to-date requirements.

Travel to Canada: For travel to Canada, any person may be denied entry to Canada for reasons including, but not limited to security risks, health issues, financial condition and involvement in criminal activity (regardless of degree or length of time since such crimes occurred) such as DUI, DWI, reckless driving, negligent driving, misdemeanor drug possession, all felonies, domestic violence, shoplifting, theft, and other crimes.
